(a) Report of Deputy Financial Officer – July 6, 2016 Re: 2016 Annual Report

Public Input

- The new flood pump is shown as a \$1.9 million expense. After the grant how much of the tax payers money has been spent or has the Village incurred in debt to complete the project?
 - Most expenses occurred in 2016, so they are not in the 2015 Annual Report. \$600,000 was long term debt and there was \$1.72 million in grant money. There was a \$200,000 surplus which came from the general surplus fund.
- Regarding the Age-friendly strategy, can it include affordable housing, I am concerned for the 35 60 year old age group. What is the expected timeline for the affordable housing strategy?
 - There is no strategy as of yet and affordable housing has not yet been discussed.
- Given that the Village has been given Age-friendly status by the Province, do they have a mandate when this has to be done?
 - There is no time limit.
- May I suggest at the Age-friendly barbeque that they have a housing/homelessness survey?
 - There will be something so we can get ideas and suggestions.

 Regarding emergency preparedness plan for the fire department. It should be done in 2016, need to invest in equipment or put money into public works or contract budget to clear out underbrush in Fire Hall Park to reduce risk of interface fires.
