The municipalities of Kent and Harrison Hot Springs joined together to develop and fund an Arts & Culture Mapping Scan for the area. The project got underway in spring of 2008. A joint Committee worked with a consultant together with public consultation to collect data.

Mr. Hilts introduced Lydia Marston-Blaauw, who was hired as a project consultant to the Spirit of BC Creative Communities Committee. Ms. Marston-Blaauw stated that she specializes in strategic planning and assessments of community needs. She was asked to do three things; cultural scan, brief needs assessments and draw conclusions with recommendations. All her information was then put in a visual form and completed in a comprehensive report. The scan includes information of what exists in both communities.

The overall message from the participants was that there was a need for more facilities and space in the Village. Ms. Marston-Blaauw thanked Mel Dunster for her assistance and thanked both communities, organizations and individuals who participated in the scan process.

The Mayor reported that he has attended various meetings with Harrison Tourism Society, Chamber of Commerce, HHS Resort and the FVRD Board in order to establish a rapport with the Village.

The Mayor reported that the FVRD has approved the establishment of a Public Advisory Committee to work with a consultant on a strategic review of transit in the Fraser Valley. They invited each partnering community to appoint a representative to take part in the Committee. The Mayor recommended that Leo Facio be invited to represent the Village.

15. QUESTIONS FROM THE PUBLIC

- P. Stenson asked for clarification on the waiving of the Memorial Hall fees. She also asked whether or not the budget costs included the cost of the operation of washrooms being open to the public. The CAO stated the budget process will review costs for operating the public washrooms. P. Stenson asked about the term of user pay.
- L. Facio stated he hoped this Council will continue in the same trend as last Council in considering the possibility of a joint facility (Village, School board, Festival venue, etc.) as there is money to do that. The Mayor stated that any facility will involve lots of public consulting before any decisions are made. The Ministry of Education has agreed to assist school district staff officials in preparing a business plan to support the possible development of a joint school board/municipal facility for consideration.
- M. Doman asked if terms of reference for Commissions will be provided and will people be invited and will positions be advertised or nominated by Council. The Mayor stated that there will be both ads and invitations for selecting to be on Committees and Commissions.
- M. Doman asked about the sani-station and if there was any guarantee that sewage won't spill into the lake. The Mayor stated that the station operates on a vacuum system. There is no guarantee, but with the type of system it is it is extremely difficult for a spill to occur. The CAO stated once the sani-station is in place, Minister Penner indicated that upon a request from us and users, the Province would take steps to designate the lake as a "dump free" lake.

M. Doman stated the Miami River would not be a good fit in the Parks & Recreation Commission. The Mayor reported he would like to see Councillor Perry come back with some recommendations.

E. Scotson asked for clarification on the Memorial Hall issues. She asked if the public would be involved in the Memorial Hall consultation process. She also asked about the plaques from the waterfront. The CAO stated they are with CHPA and will be relocated with the new Spirit Square work.

M. Doman asked if copies of the engineer's report on the Memorial Hall was available for the public. The Mayor stated yes it can be available if need be.

The CAO provided a verbal report that he met with Gerald Grahn of Preview Builders, Rob Powers of CHPA and Andy Kirkness of Krahn Engineering on January 14, 2009 to discuss the Krahn Engineering Report on the Memorial Hall. purpose of the meeting was to discuss what proposed renovations might cost and what code requirements might be required for health and safety. The building has to be viewed as a Part 3 building. The issues in question are: sprinklers, washrooms, additional entrance, structural integrity, flooring, electricity, kitchen standards, roofing and trusses, sheeting, shingles, floor repairs, seismic evaluation, insulation, windows, siding replacement, cosmetics, new ceiling, paint and replacement of the existing entrance. The CAO stated that the minimum cost could be as high as \$650,000. Following minimum improvements, we could expect up to a 15 year added life span for the building. Towns for Tomorrow grants could provide as much as \$400,000 but there is no way to determine how much in advance. The CAO also indicated that certain renovations could reduce the cost of operating by as much as 50%.

Councillor Kenyon excused himself from the Chambers at 12:15 a.m. in order to attend to another engagement.

☐ Village Safe

The Director of Finance reported on the issue of the old Village Safe. It needs to be removed to allow room for renovations. Valuables have been relocated to a secure fire proof cabinet. The Historical Society declined the offer. An old Bylaw is in place that approved the purchase of the safe and therefore Bylaw 27-1952 required approval of Council to rescind in order to dispose of it.

STRATEGIC REVIEW OF TRANSIT IN THE FRASER VALLEY

INFORMATION UPDATE JANUARY 2009

Background

The Fraser Valley Regional District (FVRD) is currently undertaking a Strategic Review of Transit in the Fraser Valley in partnership with the Ministry of Transportation and Infrastructure (MoTI), BC Transit, and TransLink. The study will develop a long-range transit vision for the Fraser Valley that will support local community plans, the Regional Growth Strategy, and the Provincial Transit Plan. The vision will create a broad outline of transit services including key measures and initiatives for the years of 2013, 2020, and 2030.

In June 2008, the partners began working to produce a Terms of Reference for the project. In early fall, both the Executive Committee and the Regional Board reviewed and adopted the draft Terms of Reference for the Strategic Review of Transit in the Fraser Valley.

Partners & Committees

On November 14, 2008 Urban Systems Ltd. was selected as the project consultant and subsequently met with the Project Steering Committee and Project Technical Committee, consisting of representatives from MoTI, BC Transit, FVRD and TransLink. During December and January, Urban Systems Ltd. also met with local government engineering and planning representatives to discuss the project and give local government staff an opportunity to provide an overview of current local transit systems as well as outline community objectives and plans in their respective communities with regards to transit.

Local government staff were also provided with copies of the draft Public Advisory Committee (PAC) Terms of Reference for review and were asked to provide the project manager with comments and an appropriate time-frame as to when respective FVRD Councils would be able to forward nominations for the Committee.

Project Committees:

Project Steering Committee (PSC): MoTI, FVRD, BC Transit, TransLink

The Project Steering Committee is comprised of representatives from each of the partner agencies and is responsible for coordinating project direction among the partner agencies, providing advice related to the Transit Strategy Review, and reporting back to the respective Partners, Regional Board, Councils, and Ministers.

Technical Committee (TC): FVRD, BC Transit, TransLink

The Technical Committee is comprised of representatives from each of the partner agencies and is responsible for providing advice on technical matters relating to each component of the study.

Transportation & Transit Technical Working Group (TTTWG): Local government staff

The Technical Working Group is comprised of engineering and planning representatives from local government and is responsible for providing direction and advice to the consultant on the integration of local community plans and objectives into a regional context, and ensuring that municipal interests are represented and incorporated into the study.

Public Advisory Committee (PAC): Membership to be established

The Public Advisory Committee will be comprised of members of the public as nominated by local councils and is responsible for providing community input and advice on transit related matters, reviewing and evaluating transit options proposed during the study, and representing a broad range of interests in the community. This is one component of what will be an extensive public consultation process.

Next Steps

Next steps in the study include the submission of the Interim Status Report by Urban Systems Ltd. in early February, in preparation for the Foundation Paper to be completed in early spring 2009. It is also anticipated that a Council of Councils will be held in the spring in order to provide a forum for dialogue and communication among the member municipalities.

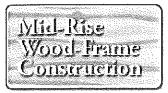

Mid-Rise Wood-Frame Residential Construction

Premier Gordon Campbell has <u>announced</u> new BC Building Code provisions which increase the maximum building height for mid-rise wood-frame residential construction from four to six storeys.

These new code provisions were approved in early January 2009 and will take effect on April 6, giving the residential construction sector time to prepare for implementation.

An online public consultation on these changes closed on December 15, 2008 and the feedback received from building industry stakeholders, local governments and the general public was considered in finalizing the changes to the new code requirements. A clear majority of consultation respondents supported the proposed changes and several adjustments were made to the original proposals in response to feedback. The exterior cladding proposal was altered to clarify the performance basis of fire resistance requirements, the shear wall integrity proposal was adjusted and the yielding diaphragm proposal was withdrawn.

Prime Minister and Premiers Agree to Accelerate Infrastructure Funding

s a result of meetings between the Prime Minister and Premiers a series of actions have been agreed upon in an effort to stimulate the Canadian economy. One of the key actions in the January 16th announcement of specific interest to local governments relates to infrastructure investments.

The Prime Minister's January 16th news release states: "The need for immediate infrastructure investments is critical. This Government has proposed to the provinces and territories to jointly occelerate planned spending to ensure that this money gets into the economy when it is most needed."

The First Ministers have agreed on an action plan in an effort to speed up the delivery of funding under the Building Canada Fund (BCF), including both accelerated funding approvals and cutting red-tape.

Of most direct significance to local governments is the federal government's indication that it is prepared to approve projects this year using the entire funding available under the BCF Communities Component. We understand that the Province of BC is also supportive of expediting approvals. In practical terms, we expect that this will mean approvals based on the first round of Communities Component applications soon and a second call for applications in the near future.

Funding under the other two components of the BCF is also being accelerated, as

follows:

- Under the Major Infrastructure

 **Component, the federal and provincial

 **Toyon means are jointly discussion
- governments are jointly discussing priority infrastructure projects that could be approved, resulting in construction starting in 2009 and 2010; and
- Under the BCF Base Fund, \$25 million
 per year was to be delivered to BC over a 7 year period from 2007/08 to 2013/14. The federal government has announced that it is prepared to give the entire remaining funding over the next two years, subject to matching provincial contributions.

The federal government has indicated that these initial actions will accelerate approval of a combined \$1.9 billion nationally in infrastructure projects beyond what was planned for the next two years.

In addition to accelerating approvals, the First Ministers agreed to cutting red tape on infrastructure projects. Of key significance to local governments are plans, over the next two construction seasons, to reduce the number of federal assessments and regulatory reviews, to simplify and develop a more efficient review process to help get projects started, and to provide clarity and predictability for Aboriginal consultation on projects.

This January 16th announcement follows a series of national consultation meetings

that federal Transport, Infrastructure and Communities Minister John Baird held with provincial, territorial, and local government leaders from across Canada. UBCM President Robert Hobson was represented at a western provincial local government associations meeting held in Vancouver on December 15, 2008.

"Local governments in BC have been making the case that there is an infrastructure gap in our communities that requires greater involvement of senior levels of government," said Mr. Hobson. "This budget begins to address our infrastructure needs and that is welcome news,"

There are a number of initiatives in Tuesday's budget that will have a direct impact on local governments in B.C. including new and accelerated infrastructure programs, funding for recreation infrastructure and money for social housing. "I am also pleased to see funding for other initiatives that directly impact the communities that we live in," said Mr. Hobson. "We welcome commitments made to First Nations, resource communities, and the sectors for tourism, arts and culture."

Mr. Hobson also indicated that in the coming days and weeks UBCM would focus its efforts to ensure that the infrastructure funding flows through to local governments as soon as possible. "There are many details to be worked out that were not contained in today's announcement and we will concentrate our advocacy efforts in these areas," said Mr. Hobson "Items such as new and 250/3 accelerated infrastructure funding and low-cost loans to local governments accelerated."

Federal Budget 2009

The 2009 Budget tabled in the House of Commons by Finance Minister Jim Flaherty accelerates and expands federal spending in infrastructure and other sectors in an effort to spur the economy.

INFRASTRUCTURE

Infrastructure Investments will be made in four kinds of projects:

- Provincial, Territorial and Municipal infrastructure
- First Nations infrastructure
- Knowledge infrastructure
- Federal infrastructure

STREAMLINED FEDERAL APPROVALS

- The Government will act to streamline federal approval processes so that more provincial, territorial and municipal projects under the Building Canada plan can start in the upcoming construction season.
- Efficiencies will be introduced through legislative amendments to the Navigable Waters Protection Act, which has not been substantially amended since 1886.
- The Government will implement administrative changes to streamline application of the Fisheries Act, and regulatory efficiencies will be pursued for projects subject to the Canadian Environmental Assessment Act. For example, for projects requiring a federal environmental assessment decision, regulations could allow one environmental assessment process to meet federal and provincial requirements, by agreement with the provinces and territories.

GREEN INFRASTRUCTURE FUND

 Provides \$1 billion over five years for a Green Infrastructure Fund. The funding will be allocated based on merit to support green infrastructure projects on a cost-shared basis.

New Funding for Communities Component of Build Canada

 Accelerates the construction of community projects by providing up to \$500 million over the next two years in new funding to the Communities Component of Build Canada to cost-share additional timely and targeted infrastructure projects.

PROVINCIAL BASE FUNDING OF BUILD CANADA

- Accelerates up to \$1 billion in payments over two years to the Provincial Territorial Base Funding Initiative to expedite "ready-to-go" infrastructure projects.
- The payments planned for the 2011-12, 2012-13 and 2013-14 fiscal years will be made in 2009-10 and 2010-11 to provinces and territories that can demonstrate the ability to put these funds to work quickly. This funding is cost-shared with the provinces and territories to maximize investment by all levels of government.

INFRASTRUCTURE STIMULUS FUND

- Establishes a new \$4-billion Infrastructure Stimulus Funthat will provide funding to provincial, territorial and municipal infrastructure rehabilitation projects.
- Funding will be available for two years for projects that will begin construction during the 2009 and 2010 construction seasons, and will be structured to flow funding and get shovels in the ground quickly.
- The federal government will approve provincial, territorial and municipal project plans, and will cover up to 50 per cent of eligible project costs. Subject to project readiness and merit, funding will be allocated for projects in provinces and territories based on their population.

RECREATIONAL INFRASTRUCTURE

- Provides \$500 million over two years to support construction of new community recreational facilities and upgrades to existing facilities across Canada. Eligible facilities include recreational facilities owned by municipalities, First Nations, counties, community organizations and other not-for-profit entities.
- The initiative will support up to 50 per cent of the total cost of eligible projects, with the balance to be provided by provincial and municipal governments, community organizations, and the private sectors.

TRAILS

 Provides \$25 million for a national initiative to create, upgrade and sustain snowmobile and all-terrain-vehicle trails in 2009/10.

FIRST NATIONS INFRASTRUCTURE

Invests \$515 million over the next two years for "ready-to-go" First Nations community infrastructure projects in three priority areas: schools, water and community services.

Infrastructure at Universities and Colleges

 Provides up to \$2 billion to support deferred maintenance and repair projects at post-secondary institutions.

BROADBAND ACCESS IN RURAL COMMUNITIES

 Beginning in 2009/10, the budget provides \$225 million over three years to develop and implement a strategy on extending broadband coverage to all currently unserved communities.

Accelerating the Repair and Maintenance of Small Craft Harbours

Provides funding for the accelerated repair and maintenance of core commercial fishing small craft harbours [e.g. \$1.9 million for building, float, fire protection, service area and wharf repairs at the Steveston (Gulf and Paramount) Harbour and \$300,000 for wharf repairs at the Ladysmith Harbour].

SOCIAL HOUSING

- Provides a one-time federal investment of \$1 billion over two years for renovations and energy retrofits for up to 200,000 social housing units on a 50-50 cost-shared basis with provinces.
- Invests \$400 million over two years for the construction of social housing units for low-income seniors.
- Invests \$75 million over two years for the construction of social housing units for persons with disabilities.
- Dedicates \$400 million over two years to new social housing projects and to the remediation of existing social housing stock on First Nations reserves.
- Supports social housing in the North with an additional \$200 million over two years.

LOCAL GOVERNMENT FINANCING

• Makes available up to \$2 billion over two years in direct, low-cost loans to municipalities to finance improvements to housing related infrastructure, such as sewers, water lines, and neighbourhood regeneration projects.

ECONOMIC DEVELOPMENT

- Provides \$1 billion over two years for a Community Adjustment Fund that will help mitigate the short-term impacts of restructuring in communities. This support for communities in all regions will be provided through regional development agencies.
- Commits \$170 million over two years to secure a more sustainable and competitive forest sector.
- Supports farmers with a \$500 million agricultural flexibility program that will help the farming sector adapt to pressures and improve its competitiveness.
- Invests \$50 million over the next three years to strengthen slaughterhouse capacity across Canada.
- Extends for one year the temporary 15-per-cent mineral exploration tax credit to help companies raise, capital for mining exploration.

ARTS & CULTURE

 Provides targeted two-year funding of \$60 million to support infrastructure-related costs for local and community cultural and heritage institutions such as local theatres, libraries and small museums.

TOURISM

- Provides \$40 million to the Canadian Tourism Commission over two years to support marketing activities, such as the Vancouver 2010 Winter Olympics and Paralympic Games.
- Commits \$100 million over two years for marquee festivals and events that promote tourism.
- Provides \$75 million over two years for improvements and enhancements to Parks Canada's visitor facilities (e.g. campgrounds, visitor centers) and an additional \$75 million to Parks Canada for upgrades to National Historic Sites.

ENVIRONMENT

- Provides \$300 million over two years to the EcoENERGY retrofit program to support an additional 200,000 home retrofits.
- Commits \$80 million over the next two years to manage and assess federal contaminated sites, facilitating remediation work totaling \$165 million over two years.

The project will replace a failed culvert with a current standard, clear span bridge. The upgraded structure will improve the safety for travel throughout the entire village. Including previous work done since the existing culvert failed last year, the BC Government has committed a total of \$2.3 million for this project.

The contract award amount for the project is \$1,162,841.10 and was awarded to Jakes Construction Ltd. of Chilliwack. Construction is set to begin this winter and finish in May 2009. Motorists can expect detours during construction as the Miami Bridge will be closed and traffic will be re-routed.

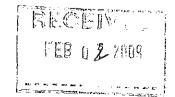

RECOMMENDATION:

THAT Council receive this report; and

THAT Council approves option 3: that is approve the application and proceed with the evaluation subject to receipt of approval for planning grant assistance.

BACKGROUND:

At Council meetings in the past there has been some call for investigation into whether or not we need to go further in our work to ensure adequate, safe domestic water supply for the Village.

As you know, the Village obtains its water from an open surface source namely Harrison Lake. As such we have received notice from the Public Health Inspector indicating that on or before December 31, 2010, we can only deliver this water for domestic use provided that it has undergone treatment to achieve the following:

- 1. At least 4-log (99.99%) reduction and inactivation of viruses;
- 2. At least 3-log (99.9%) reduction and inactivation of Giardia cysts and oocysts;
- 3. At least 3-log (99.9%) reduction and inactivation of Crypotosporidium cysts and oocysts.

A fully underground source supply with an appropriate GUDI (Ground Under Direct Influence) rating could provide domestic service with virtually no source treatment. Inevitably though treatment of the distributed water is necessary when the distribution system downstream of the storage system (reservoir) is existing or not new throughout.

DISCUSSION:

Staff has discussed with our consulting engineer options for treatment of the source supply as well as ongoing treatment of the distribution supply. By incorporating the treatment of both source and distribution at the same time is preferred as this is usually more economical and user friendly.

Can the treatment of our water supply either source or distribution or both be provided economically at this time with the reservoir works? Staff asked Dayton & Knight for a proposal to provide some options.

There proposal is attached for your information.

BUDGETARY CONSIDERATIONS:

Currently water reserves or DCC's would be adequate to cover the cost of this evaluation work. This would also be eligible for an Infrastructure Planning Grant. The grant could cover up to approximately one half the quoted cost up to a maximum amount of \$10,000.00. Application intakes are ongoing and typical responses come back within 6 to 8 weeks.

POLICY CONSIDERATIONS:

The application process requires a resolution of council.

ALTERNATIVES/OPTIONS:

Option one is not approve application for Planning Grant assistance and wait until 2010 to schedule this work;

Option two is to approve application for Planning Grant assistance and wait for approval of the 2009 budget before proceeding;

Option three is to approve application for Planning Grant assistance and utilize municipal share of funds from the DCC's or water reserves. PREFERRED

Further to our conversation dated November 26, 2008 we are pleased to submit the following proposal for the assessment of the Village of Harrison Hot Springs water treatment program.

1.0 BACKGROUND

The Village of Harrison Hot Springs currently obtains its water from an intake in Harrison Lake, approximately 1,000 m from the shoreline. The water is pumped to a reservoir with a top water level of 50 m, west of Balsam Road. At Balsam Road, the water is chlorinated prior to discharging into the reservoir. A separate outlet from the reservoir brings the water to the distribution system. The intake and pumping station was installed in 1999/2000.

It is understood that the Village has received correspondence from the Public Health Inspector in January 1993 indicating that the Village must, on or before December 31, 2010, have finished water that has undergone treatment to achieve the following:

- 1. At least 4-log (99.99%) reduction and/or inactivation of viruses.
- 2. At least 3-log (99.9%) reduction and/or inactivation of Giardia cysts and oocysts
- 3. At least 3-log (99.9%) reduction and/or inactivation of Crypotosporidium cysts and oocysts.

Dayton & Knight has been involved in water sampling of Harrison Lake for the City of Abbotsford, and as such, we have extensive knowledge of the water quality within the lake. The Village has requested that Dayton & Knight Ltd. undertake a program to determine the best source of water that would meet the above requirements. Although a detailed investigation is not planned at this time, sufficient sampling will be undertaken to enable the Village to address any

additional issues that may be raised by health as a result of the changes to the drinking water requirements since 1993.

2.0 SCOPE

Our proposed scope of work is broken down into three separate categories: sampling and review of existing intake water, review of a supply from a deeper intake, and review of groundwater supply.

2.1 Existing Intake

In order to establish the treatment necessary to meet the requirements set by the Public Health Officer, the water quality of the current source requires being determined. We propose to take bi-monthly water samples (January, March, May, July) for a 7-month period from within the existing raw water pump station and undertake chemical and physical analysis on the samples.

Samples for chemical and physical analyses would be delivered to Bodycote Laboratories in Surrey (see attached fee proposal from Bodycote). Bacteriological testing would also be included in these analyses. Table 2-1 provides the parameters that are proposed for the laboratory testing program.

If turbidity levels in the source are less than 1 NTU and other physical and chemical properties of the water are acceptable at the existing intake location, ultraviolet (UV) treatment may be adequate to meet the requirements. In order to establish the turbidity

levels of the source water, we recommend that the Village install an online turbidimeter on the source water at the intake pump station and log turbidity readings.

We propose to review and summarize water quality data from the existing intake location and provide general comments on the suitability as a water source (treatment required, capital cost, etc.).

2.2 New Intake

The south end of the lake is relatively shallow, and the existing intake is in water ranging in depth from 3-8 m, depending on seasons and tides. The existing intake was installed in 1999, under the assumption that it be extended in the future.

In 1996 Dayton & Knight undertook a water supply study which recommended extending the existing intake to the 20 m depth, south west of Echo Island. This location is approximately 2,600 m from the existing intake. We have previously undertaken a quarterly sampling program for the City of Abbotsford approximately 2 km from this location, in depths of approximately 20-50 m. We have also previously undertaken, in conjunction with the University of BC, a general study of the water quality in Harrison Lake, and as such we are able have substantiated confidence that the location recommended by Dayton & Knight in our previous report would still be suitable today.

We propose to review and summarize the past data gathered by Dayton & Knight as well as UBC and to provide general comments on the new intake location (treatment required, capital cost, etc.). If this location is confirmed, further investigation will be required (lake bed sediment sampling, etc.).

2.3 Groundwater

It is understood that the Village may consider using groundwater as a water supply, should it be a viable option. We have previously undertaken a reservoir study for the Village, a portion of which reviewed the potential for supplying water from groundwater. Results from that study indicated that at that time the groundwater sampled was relatively high in iron and manganese, as well as turbidity. However, these results were from shallow wells. It is understood that there are private wells in the vicinity that may have good water quality. The capacity of these wells is not known at this time. We propose to review this study and subsequent groundwater studies that have been undertaken to provide a recommendation for further investigation.

Should a groundwater supply be feasible, the next step would be to initiate a groundwater investigation program. This type of program is proposed to involve a desktop study and subsequent drilling program. Estimated costs for this type of program would be in the order of \$10,000 - \$15,000 for the desktop study and \$50,000 - \$100,000 for a drilling program.

3.0 DATA ANALYSIS AND REPORTING

A letter report will be prepared to present the results of the study and water quality monitoring. The report will include order of magnitude cost estimates as well as a recommendation for further investigation.

4.0 PROJECT TEAM

The project team all have qualifications and experience in projects of similar scope to the proposed work. Mr. John Boyle, P.Eng., Mr. Joel McAllister, P.Eng., Ms. Claire Bayless, P.Eng., and Ms. Stephanie Lapointe, EIT, from Dayton & Knight Ltd. will oversee the project, data collection and analysis. Mr. Sean Brophy, P.Eng. will be a Specialist Advisor on the team.

Samples will be delivered to Bodycote Laboratories in Surrey for analyses.

5.0 SCHEDULE

This program is scheduled to start in January 2009. Sampling would continue until July 2009. It may be feasible to extend the sampling program further into the summer in order to see the effect of recreational use and increased temperature on the water quality at the existing intake.

It is anticipated that the final report would be presented in August 2009.

6.0 FEES AND DISBURSEMENTS

A detailed cost breakdown for the proposed program follows as Table 6-1.

We propose to undertake the above for the lump sum price of \$20,285.00, excluding GST. This does not include the cost of online turbidity monitoring as recommended in Item 2.1.

Disbursements will be charted at cost plus 5%. Disbursements will include sample shipping, long distance phone and fax charges, courier and printing costs, and mileage charges at \$0.52 per km.

VILLAGE OF HARRISON HOT SPRINGS BYLAW NO. 904

A bylaw enacted for the borrowing of such sums of money that may be necessary to meet the lawful current expenditures of the Municipality.

WHEREAS, Section 177 of the Community Charter provides that a

Council may, by bylaw, provide for the borrowing of money that may be necessary to meet the lawful current expenditures of the Municipality, provided that the total debt under this section does not exceed the unpaid taxes for all purposes imposed during the current year and the money

remaining due from other governments;

AND WHEREAS, the taxes in the current year are deemed to be 75% of all

property taxes imposed for all purposes for the preceding

year;

AND WHEREAS, the amount of all property taxes imposed for all purposes in

the preceding year, is \$3,385,522 and 75% of this amount is

\$2,539,141;

NOW THEREFORE, the Council in open meeting assembled, HEREBY ENACTS

AS FOLLOWS:

(1) It shall be lawful for Council to borrow upon the credit of the Village, from the Prospera Credit Union, the sum of two million five hundred thirty-nine thousand dollars (\$2,539,000), in such sums and amounts and at such times as may be required, and to pay interest at the Prime Rate per annum.

- (2) The form of obligation or obligations to be given as acknowledgement shall be a Promissory Note bearing the Corporate Seal and shall be signed by the Mayor and Director of Finance of the Village.
- (3) There is hereby set aside as security for the liability here authorized to be incurred, two million five hundred thirty-nine thousand dollars (\$2,539,000), being that part of the taxes for the current year deemed by the Village Council expedient to be so set aside.

- (4) That Revenue Anticipation Borrowing Bylaw No. 854, 2006 be repealed in its entirety.
- (5) That this bylaw may be cited for all purposes as "Revenue Anticipation Borrowing Bylaw NO. 904, 2009".

it is provided by Section 181 of the *Community Charter* that the Council may, where it has adopted a loan authorization bylaw, without further assents or approvals, borrow temporarily from any person under the conditions therein set out;

AND WHEREAS: the Council has adopted Bylaw No 887, cited as A Loan Authorization Bylaw authorizing the construction of a new sewer line to the District of Kent's wastewater treatment plant, in the amount of three million one hundred thousand dollars (\$3,100,000.00);

AND WHEREAS: the sale of debentures has been temporarily deferred:

NOW THEREFORE: the Council of the Village of Harrison Hot Springs in open meeting lawfully assembled, enacts as follows:

- 1. The Council is hereby authorized and empowered to borrow an amount or amounts not exceeding the sum of three million one hundred thousand (\$3,100,000.00), as the same may be required.
- 2. The form of obligation to be given as acknowledgement of the liability shall be a promissory note or notes bearing the corporate seal and signed by the Mayor and the Director of Finance.
- 3. The money so borrowed shall be used solely for the purposes set out in said Bylaw No.887.
- 4. The proceeds from the sale of the debentures or so much thereof as may be necessary shall be used to repay the money so borrowed.
- 5. This bylaw may be cited as "Kent Sewer Line Temporary Borrowing Bylaw No. 905".
