VOTING DATES AND LOCATIONS

GENERAL VOTING DAY will be:

Saturday, October 15, 2022, between 8:00 am and 8:00 pm at: Harrison Hot Springs Elementary School, 501 Hot Springs Road

ADVANCE VOTING will be held as follows:

Wednesday, October 5, 2022 between 8:00 am to 8:00 pm at:

Village of Harrison Hot Springs Council Chambers, 495 Hot Springs Road

ELECTOR REGISTRATION

There is no need to pre-register to vote as the registration of all electors for this election will take place at the time of voting. You will be required to make a declaration that you meet the following requirements:

- 18 years of age or older on general voting day October 15, 2022;
- Canadian citizen;
- a resident of BC for at least 6 months immediately before the day of registration;
- resident on the day of registration **OR** registered owner of real property in the Village of Harrison Hot Springs for at least 30 days immediately before the day of registration; and
- not be disqualified under the *Local Government Act* or any other enactment from voting in an election or assent voting and not otherwise disqualified by law.

NOTICE OF ELECTION BY VOTING

Resident electors must produce **2 pieces of identification** (at least one with a signature). Picture identification is not necessary. The identification must prove both residency and identity.

Non-resident property electors must produce **2 pieces of identification** (at least one with a signature) to prove identity, **proof** that they are entitled to register in relation to the property, and, if there is more than one owner of the property, **written consent** from a majority of the registered owners stating that the elector is an owner of the property, and is designated as the Non-Resident (Property) Elector for that property.

TYPES OF DOCUMENTS THAT WILL BE ACCEPTED AS IDENTIFICATION

- a) a BC Driver's Licence;
- b) a photo or non-photo BC services card;
- c) an Owner's Certificate of Insurance and Vehicle Licence issued by ICBC
- d) a BC CareCard or BC Gold CareCard;
- e) a Ministry of Social Development and Economic Security Request for Continued Assistance Form SDES8, (now "Monthly Form EA181);
- f) a Social Insurance Number card;
- g) a Citizenship Card issued by Citizenship and Immigration Canada;
- h) a real property tax notice;
- i) a credit card or debit card; or
- j) a utility bill, (such as electricity, natural gas, water, telephone or cable services).

MAIL BALLOT VOTING

REQUESTING A MAIL BALLOT PACKAGE:

If you wish to vote by mail and in order to obtain a mail ballot, you must submit an application form with the information as listed below by 4:00 pm on October 7, 2022. The application form is available at the Village Office, 495 Hot Springs Road, Harrison Hot Springs, BC, or may be downloaded on the Village website at <u>harrisonhotsprings.ca</u>.

(1) Full name,

- (2) Residential address,
- (3) Address of the property in relation to which you are voting (for non-resident property electors),
- (4) Requested method of delivery of your mail ballot package:
 - pick up at Village Office, OR
 - regular letter mail through Canada Post to residential address, OR
 - regular letter mail through Canada Post to an alternate address that you provide when requesting the ballot package, and

(5) To ensure you receive the correct registration application in your package, you must indicate whether you are going to be registering as a resident or non-resident property elector.

The Village will send out mail ballot packages commencing on or about October 3, 2022. To be counted, your mail ballot must be received by the Chief Election Officer no later than 8:00 pm on Saturday, October 15, 2022 of General Voting Day.
