SUBJECT: 2022 Municipal Election Results

ISSUE: Results of the 2022 Municipal Election

BACKGROUND:

The General Voting Opportunity for the Offices of Mayor and Councillor for the Village of Harrison Hot Springs and School Trustees for School District #78 was held on Saturday, October 15, 2022 at the Harrison Hot Springs Elementary School. In addition, an Advance Voting Opportunity was also held at the Village Office Council Chambers on October 5, 2022 (required under s. 107 of the *Local Government Act*).

Mail Ballot Voting was also available to electors. The Village received twelve (12) requests for Mail in Ballot packages. Eleven (11) Mail in Ballot packages were received in time for the Ballot count on October 15, 2022. Of the eleven (11) received, three (3) of the packages were rejected due to incomplete Certification Envelopes resulting in eight (8) accepted ballots. Mail ballot voting is an optional provision under the *Local Government Act* (s.110). Because there are very few electors in the Village who take advantage of this opportunity and the amount of work and cost associated with providing this service, staff is recommending that it be removed from the General Election and Other Voting Procedures Bylaw No. 1121, 2022. There are 31 municipalities in British Columbia who do not provide this service, according to a survey completed by CivicInfo in 2022.

The estimated number of eligible voters for the Village of Harrison Hot Springs was 1,598. The total number of ballots cast in the 2022 municipal election was 775, resulting in a 48% voter turnout.

The Determination of Election Results was made on Wednesday, October 19, 2022 in the Council Chambers at the Village Office. The number of votes for each candidate was unchanged from the Preliminary Results announced at the close of the General

Voting Opportunity on October 15, 2022. The Official Results for the 2022 Municipal Election was declared on October 19, 2022 as follows:

DISCUSSION:

One candidate for councillor withdrew prior to the deadline for withdrawal of nomination packages. There were no declarations of ineligible candidates or challenges.

Election signage was prevalent throughout the community. The current Sign Bylaw under s. 2.1 General Requirements and s. 5.12 Election Signs do not align. Therefore, staff is recommending that provisions for election signage be removed from the Sign Bylaw and be included in the General Election and Other Voting Procedures Bylaw.

The election process ran smoothly for both the Advanced Voting Opportunity and the General Voting Opportunity. However, the Village Office was not sufficient in size for the advanced voting opportunity which had a relatively high turnout in comparison with previous years and lacked adequate lighting. While the Harrison Hot Springs Elementary School was sufficient in size for the General Voting Opportunity, it was not fully accessible and a temporary ramp was installed. Staff suggests that future elections take place at Memorial Hall.

The election staff worked tirelessly throughout the entire voting process and their assistance and dedication to the integrity of the election was greatly appreciated. The Automated Voting Tabulators were used by the Village in the 2018 and 2022 elections and assisted in an efficient and accurate tabulation of the ballots. Same day registration of electors continued to work well.

RECOMMENDATIONS:

THAT staff bring forward draft amendments to remove the mail ballot voting provisions and include provisions for the placement of election signage in the General Election and Other Voting Procedures Bylaw No. 1121, 2022;
